

**TERMS AND CONDITIONS FOR JAPAN QUILT SOCIETY**  
**INDIVIDUAL Membership and CORPORATE Membership**

Japan Quilt Society (hereinafter referred to as 'JQS') aims to develop and promote quilt culture in Japan.

JQS is a membership organization for quilters and corporate members. JQS strives to spread the technique, knowledge and skills of quilts and nurturing the young quilters in Japan

These terms and conditions only apply to JQS and JQS Individual/Corporate members.

**Membership Application**

You are requested to submit an admission form to JQS via mail, fax, email and pay 1-year membership fee.

Payment is acceptable by credit card or bank transfer methods.

With payment of 1-year membership fee, your membership application is approved.

**Annual Membership Fee**

1) JQS Individual Members: 3,300 JPY (tax included)

2) JQS Corporate Members: 33,000 JPY (tax included)

JQS membership runs for 12 months from the month you join.

From the next year onwards, members can renew and maintain their membership by paying their annual dues by the end of their starting month.

**Member Benefits**

As an JQS Individual Member, you receive; 1) JQS Membership Card, 2) 2 issues of JQS Quilters Magazine (March and September), 3) Exclusive Savings at JQS (admission, contest, classes, and more)

JQS Corporate Member can receive the benefits of; 1) JQS Membership card, 2) 2 issues of JQS Quilters Magazine (10pax each), 3) Exclusive Savings at JQS (vendor booth fees, admission, advertising fees on JQS magazine, and more).

**Notification upon Personal Information changes**

JQS members' personal information needs to be accurate and up to date. Members are requested to inform JQS of new personal information if there's any change.

**Revocation of Membership**

In the following cases, membership can be forcibly revoked at the discretion of JQS.

- When a member does not pay their annual fee by due date.
- When false or fraudulent is found in the member's application documents.
- When it becomes clear that a member breaks Japanese laws and regulations.
- When a member makes a statement or behavior that damages the credibility of JQS and the membership qualification.
- When a member acts to damage the honor of others.
- When it becomes clear that the rights held as a member are transferred to others, sold, changed in

name, or other acts such as providing collateral.

- When JQS determines that the qualification of the acquirer is not appropriate, such as in violation of this terms and conditions.

### **Withdrawal from Membership**

Members may request to withdraw from the membership at any time by notifying JQS in writing. However, in the case of withdrawal or loss of membership in the middle of the year, the annual membership fee already paid will not be refunded.

### **How JQS Use Your Personal Information**

JQS collects members' personal information to be used for following.

- To provide services from JQS to members
- To contact and provide information from JQS

Members' personal information shall be handled appropriately in accordance with the personal information protection policy.

### **Disclaimer**

- JQS is not responsible for any damages caused by the use of the services provided to the members, except in the case of intentional or gross negligence by JQS.
- Members shall be responsible for any damages caused to JQS intentionally.

### **Disclosure of Corporate Members**

JQS Corporate Members shall agree to disclose their names, contacts, logo data, etc. on JQS official website.

### **Governing Law and Legal Jurisdiction**

These terms and conditions shall be governed by all applicable Japanese laws, and for any controversy or claim resulting out of or relating to these terms and conditions shall be settled in the Tokyo Summary Court or the District Court of Tokyo.

### **Changes to our terms and conditions**

JQS may review and update these terms and conditions as deemed appropriate without notification. The revised terms and conditions will effective immediately upon posting of the JQS website.
